Important information for the vendor:

- Vendors will be responsible for bringing their own shelter (tent), weather protection, tables & chairs.
- Display set-up begins at 7 a.m. the day of the event. We would appreciate if you can stay for the entire Taos PRIDE in the Park event.
- Assigned booth spaces will be the standard 10 x 10 feet (if more space is needed you may pay for two spots. If you are a non-profit organization your first space is free but any additional space(s) you will need to pay for).
- Vendors are responsible for their materials and property. Taos Pride is not responsible for lost or stolen items.
- Town of Taos prohibits: Consumption or sale of alcoholic beverages except at the designated area; Glass Containers; Unleashed dogs; Skateboarding; Overnight stays.

Concessionaires and Exhibitors are required to carry General Liability Insurance coverage of at least \$1,000,000 that protects them and names Taos Pride as an additional insured on the policy. Please provide proof of insurance with your vendor application.

Please send your completed and signed application, your payment made out to Taos Pride, and your proof of insurance. You may make one check out to Taos Pride for the Vendor Booth fees. If you are getting a Special Business License you can make the \$10 check out to The Town of Taos. If you are paying \$25 for electric inspection and use make the check out to the Town of Taos. If you are using propane make the \$15 check payable to Robert Sloan.
